

## Garda Vetting Verification of Identity

### LIST OF ACCEPTABLE DOCUMENTS

The **100-point check** is a personal identification system, this information sheet has been developed to support organisations in verifying identity including date of birth and current address of vetting subjects (those applying to be Garda Vetted).

**Note:** Public Service Cards are no longer accepted as forms of identification.

Applicants must present identification that display their **name, date of birth, current address and a photograph. ID must reach a minimum of 100 points.**
